NOTICE OF OTHER RELEVANT INFORMATION

Pursuant to articles 227 and 228 of the Spanish Royal Legislative-Decree 4/2015, dated 23 October, approving the consolidated version of the Spanish Securities Market Act, articles 5 and 17 of Regulation (EU) no. 596/2014 on Market Abuse, Delegated Regulation (EU) 2016/1052 supplementing Regulation on market abuse with regard to regulatory technical standards for the conditions applicable to buy-back programmes and stabilisation measures, and other applicable regulations, CIE Automotive, S.A. (hereinafter, the “**Company**”) hereby reports that as a continuation of the notice of other relevant information published on February 28, 2020 (registration number 644) relating to the establishment of a share buy-back programme, the Company hereby reports the transactions carried out over its own shares between 23 and 30 October 2020 (both inclusive), under the share buy-back programme approved by the Board of Directors of the Company in accordance with the authorization granted by the General Shareholders’ Meeting.

Consequently, it is hereby reported that the share buy-back programme has come to an end prior to its maturity.

Pursuant to the reported purpose of the share buy-back programme (redemption of the own shares), CIE Automotive will start the necessary formalities to reduce the share capital of the Company through the redemption of the 6.450.000 acquired shares (representative of 5% of the share capital of the Company on the date hereof).
